# ARPEGE, ALADIN, ALARO, HIRALD, AROME.

One code, but several models shared between different European (and also some non-European countries) :

- ARPEGE : spectral global model for METEO-FRANCE applications.
- IFS : spectral global model for ECMWF applications.
- ALADIN : spectral limited area model (mesh-size often around 10 km).
- ALARO : cf. ALADIN but for some ALADIN partners, (mesh-size around 5-7 km).
- AROME : non-hydrostatic spectral limited area model for METEO-FRANCE applications (mesh-size 2.5 km) ; planned for operations in 2008.
